City & County of San Francisco

San Francisco officially the City and County of San Francisco, is the cultural, commercial, and financial center of Northern California. San Francisco is the 13th most populous city in the United States, and the 4th most populous in California, with 884,363 residents as of 2017. It covers an area of about 46.89 square miles, mostly at the north end of the San Francisco Peninsula in the San Francisco Bay Area, making it the second most densely populated large US city, and the fifth most densely populated U.S. county, behind only four of the five New York City boroughs. San Francisco is also part of the fifth most populous primary statistical area in the United States, the San Jose–San Francisco–Oakland, CA Combined Statistical Area (CSA) with (8.8 million residents).

As of 2016, it was the 7th highest-income county in the United States, with a per capita personal income of \$110,418. The San Francisco CSA was the country's 3rd largest urban economy as of 2017, with a GDP of \$878 billion. Of the 574 primary statistical areas in the US, the San Francisco CSA had the highest GDP per capita in 2017, at \$99,347 per capita. San Francisco is ranked 8th in the world and 2nd in the United States on the Global Financial Centres Index as of 2018.

A popular tourist destination, San Francisco is known for its cool summers, fog, steep rolling hills, eclectic mix of architecture, and landmarks, including the Golden Gate Bridge, cable cars, the former Alcatraz Federal Penitentiary, Fisherman's Wharf, and its Chinatown district. San Francisco is also the headquarters of five major banking institutions and various other companies such as Levi Strauss & Co., Gap Inc. Fitbit, Salesforce.com, Dropbox, Reddit, Square, Inc., Dolby, Airbnb, Pacific Gas and Electric Company, Yelp, Pinterest, Twitter, Uber, Lyft, Mozilla, and Wikimedia Foundation, Craigslist. It is home to a number of educational and cultural institutions, such as the University of San Francisco (USF), University of California, San Francisco(UCSF), San Francisco State University (SFSU), the De Young Museum, the San Francisco Museum of Modern Art, and the California Academy of Sciences.

As of 2017, San Francisco is the highest rated American city on world liveability rankings.

City & County of San Francisco Government

San Francisco is the only combined city and county in California. Its governing powers are vested in an eleven-member Board of Supervisors elected by district, with each serving a four-year term.

The Mayor – the chief executive of the city – is elected by the voters for a four-year term, as are the City Assessor, Treasurer, City Attorney, Public Defender, District Attorney, and Sheriff. Mayor London Breed was elected in 2018 as the 45th Mayor for the City and County of San Francisco.

As the governing and policy-making body of SFDPH, the San Francisco Health Commission is mandated by City & County Charter to manage

and control the City and County hospitals, monitor and regulate emergency medical services, and all matters pertaining to the preservation, promotion and protection of the lives, physical health and mental health of San Francisco residents.

Department of Public Health

The San Francisco Department of Public Health (SFDPH) is the largest department within the City and County of San Francisco. With an annual operating budget of \$2.2 billion, SFDPH employs over 8,000 people, and contracts for more than \$400 million in community-based services.

The San Francisco Department of Public Health is an integrated health department with two major divisions to fulfill its mission of protecting and promoting the health of all San Franciscans:

- The San Francisco Health Network (SFHN) includes top-rated hospitals, clinics and programs that provide medical, mental health, and substance abuse services to over 100,000 individuals. SFHN includes Zuckerberg San Francisco General Hospital, the only local Level 1 Trauma Center for San Francisco and Laguna Honda Hospital and Rehabilitation Center, the largest public skilled nursing facility in the Country; and
- The SFDPH Population Health Division (PHD), which earned public health accreditation in 2017, carries out traditional and mandatory public health functions such as: consumer safety activities; health promotion and prevention; inspections of food, alcohol, and cannabis businesses; promote improved air and water quality; promote pedestrian safety; HIV prevention, research and surveillance; TB prevention and treatment; Emergency Medical Services; and analysis of community public health data.

SFDPH's central administrative functions, including finance, human resources, information technology, and policy and planning, support and promote integration between SFDPH's two divisions. The SFDPH is committed to providing quality health care and public health services to all San Franciscans regardless of immigration or insurance status. The Position

Under broad policy direction from the Health Commission and the Mayor, the Director of Public Health plans, organizes, directs and evaluates all functions and activities of the Department, including: hospitals, primary care, mental health services, substance use services, jail health services, preventative health services, emergency medical services, environmental health, and other population health functions.

The Director is responsible for management of a \$2.2 billion budget and 8000 + employee department, as well as administration of \$400 million in health of services contracts.

Additionally, the Director of Public Health directs the enforcement of all public health laws, ordinances and regulations; oversees budget preparation for approval of the Commission; establishes and maintains community and professional interest in public health matters; develops policies and programs to address the needs of SFDPH and the health of the community.

The essential functions of this position include:

- Executive Leadership: Leads the Public Health department; develops and recommends general health policies for approval by the Health Commission; works with the Mayor and Health Commission on strategies to implement health policies and initiatives that advance San Francisco's public health goals; and collaborates with the Board of Supervisors on health issues facing San Franciscans.
- Visionary with Strong Implementation Skills: Provides a
 vision to continue the innovative and ground-breaking
 legacy of the San Francisco Health Department. Establishes
 and maintains strategic short and long-term goals,
 objectives and plans that are culturally and technologically
 relevant for carrying out departmental functions, consistent
 with overall City and County of San Francisco strategic goals.
- Operational Responsibilities: Plans, organizes, directs, controls, and reviews the operation of all departmental functions and activities including San Francisco Health Network, Population Health Division and Central Administration; ensures compliance with a broad range of regulations and policies.
- Collaborative Manager: Supervises division leadership, deputy directors, institutional administrators, and staff with wide-ranging responsibilities throughout the department. Promotes the highest standards for interpersonal relations, including effective listening skills, high degree of emotional intelligence, teamwork, negotiation, and problem-solving.
- Administrative Excellence: Directs the development of the annual budget and capital improvement programs for Commission consideration and approval; recommends contractual services and is responsible for the implementation, control, monitoring and evaluation of services.
- Political Awareness: Communicates regularly with the Mayor in regard to SFDPH's activities; coordinates program and policy efforts with other city departments; works constructively and collaboratively with the Board of Supervisors, community groups and stakeholders toward San Francisco's public health goals.
- Builds and manages the relationship with the University of California, San Francisco: Manages, supports, and enhances the 150-year relationship between the Department of Public Health and the University of California, San Francisco. Works to strengthen ties, foster new partnerships and increase collaboration between the two organizations.

- Partner with the Community: Collaborates with the community to address community health needs: devises programs using effective harm reduction strategies that respond to the needs of diverse communities of San Francisco with particular attention to underserved populations, health equality, and those with special health care needs; understands the impact of social determinants of health on the San Francisco community.
- Health Policy Leader: Provides leadership and public health expertise in the local policy-making and legislative process, as well as advocacy and engagement in state and federal health policy or regulatory changes impacting the department or the community. Understands, advocates, and actively participates in a broad range of planning to address health issues as they pertain to diverse populations, including issues impacting the health and wellbeing of underserved populations.

When the Director of Public Health is a licensed physician, performs the duties of the County Health Officer as required by California Code. These duties include: enforces orders, regulations, rules and statutes, and takes preventive measures during an emergency, pursuant to California Code. If the Director of Public Health is a non-physician, a physician is appointed to perform the functions of the County Health Officer.

The Ideal Candidate

The Ideal Candidate for Director of Health will be a strong, passionate leader who is committed to public service, public health and our community. Additional personal attributes and characteristics strongly desired in this accomplished professional will include being a:

- Progressive and engaged leader who embraces partnering, collaboration, innovation, and transparency;
- Thoughtful, analytical and reflective thinker who understands the community-based impacts of various organizational decisions;
- Visionary and forward-looking executive who is innovative and open to new ideas and ways to approach healthcare;
- Strategic administrator who understands the breath and complexity of the department;
- Extraordinary person respected for political astuteness, business acumen, honesty, integrity, and compassion; and
- Continuous improvement promoter who is highly responsive, adaptable to organizational change, and capable of delivering results.

Additionally, the Ideal Candidate for Director of Health will embrace the mission for SFDPH and have a passion for:

- Assessing and researching the health of the community;
- Developing and enforcing healthy policies;
- Preventing disease and injury;
- Educating the public and training healthcare providers;
- Providing quality, comprehensive, culturally-proficient health services; and
- Ensuring equal access to all.

In summary, the Director of Health will be a skilled professional able to manage a complex organization, oversee staff, offer significant contributions and, at the same time, be true to SFDPH's mission.

Experience and Education

Education: Possession of a baccalaureate degree from an accredited college or university.

Experience: 8 – 10 years of leadership experience in a large, health-related organization including supervisory experience.

Desirable Qualifications:

- M.D., D.O. or master's degree in health administration or a related field.
- Experience in clinical integration, access, quality of healthcare and cost of healthcare issues; thorough understanding of clinical practice, and patient care.
- Demonstrated diplomacy and sensitivity in communicating with elected officials, community organizations, and various stakeholders.
- Experience developing health policy and understanding of public health research.
- Effective interpersonal and communication skills which demonstrate an ability to work successfully across the organization and community.
- Cultural humility and understanding of issues confronting diverse communities, including underserved populations; experience working with and commitment to diverse, community based non-profit organizations.
- Experience with leading organizational change or process improvement, including experience and/or training in Lean methodologies.
- Successful experience working within a unionized labor environment; experience negotiating with unions and building and enhancing partnerships with labor.
- Senior leadership role in another public health agency.



Appointment Type

This is an exempt position within the City and County of San Francisco's civil service system. The Director of Public Health is the administrative head of San Francisco Department of Public Health and serves at the pleasure of the Mayor and the Health Commission.

Compensation and Benefits

The annual salary range for the Director of Health is \$243,490 to \$310,726. Appointments above this range may be considered for a top candidate.
